Hire Incentives for Employers



Take advantage of tax incentives, funding, and programs for hiring students, young innovators and youth talent for your business, not-for-profit or public-sector organization.

Apprenticeship Training Tax Credit

How to get a tax credit if you hire and train apprentices in certain skilled trades.

Catapult Microloan Fund

Get a microloan to fund your social enterprise. If your business solves a social, environmental, cultural or economic problem, you could receive a loan of \$5,000-\$25,000.

Northern Ontario Internship Program

Get up to \$31,500 toward the salary of an intern with your Northern Ontario company. The person you hire must have graduated from an accredited college or university within the last three years.

Ontario Co-Operative Education Tax Credit

Get a tax credit when you hire co-op students. A maximum credit of \$3,000 is available for co-op employees who work between 10 weeks-4 months.

Ontario Youth Apprenticeship Program

Find out how you can help train – and benefit from – a new generation of apprentices in the skilled trades.

Youth Job Connection

Get money to help pay for training and salary when you hire a young person who's been through pre-employment training.

Youth Job Link

Get help hiring skilled young people, including help placing job advertisements and matching with suitable job candidates.



Youth Job Connection - Summer program:

The Youth Job Connection-Summer program is launching in April 2016. It will provide summer job opportunities to students aged 15 to 18 who are facing challenging life circumstances and may need support transitioning between school and work. Participants of the Youth Job Connection- Summer program will be completing preemployment training before proceeding to a job placement. Youth will receive ongoing support to ensure successful employment. Funding is available to eligible employers to assist with job placements and to train program participants.

The Employment and Education Centre also offers employment services to young people who are looking for summer jobs and don't fit the parameters of the Youth Job Connection – Summer program. This includes access to summer jobs listed on the agency's web site (www.eecentre.com), one-on-one assistance with an employment coach, and access to EEC's job preparation workshops.

Youth Job Link

Youth Job Link launched on April 1st and is designed to assist youth between the ages of 15 and 29 who do not face significant barriers to employment, but can benefit from some extra help to plan their careers and transition to the labour market.

Additional employment services provided as part of this program will encompass career exploration services to increase knowledge of career options and support career decision -making; career management services to improve readiness for the labour market; and, job search readiness and matching assistance to connect youth with employers offering employment opportunities, including summer jobs and part-time employment during the school year.

For employers, Youth Job Link offers employers free job postings, pre-screening and referral of potential candidates, job matching services, and access to a pool of accessible students. In some instances, employer incentives may be available to offset hiring related costs, these incentives are only available for youth who have never previously held paid employment.

The program is funded by the Ministry of Training, Colleges and Universities.
